A reference is invited to Ministry of Finance, Department of Expenditure OM no. 1(18)/PFMS/FCD/ 2021 dated 9th March, 2022 (copy enclosed) regarding revised procedure to be followed for flow of funds under Central Sector Schemes w.e.f. 01.04.2022. As per above OM, schemes (1) Innovation Technology Development and Deployment and (2) Research and Development of DST having an annual outlay of more than Rs.500 crores were identified for flow of funds under Model 1.Further, as per above OM dated9th March, 2022 CNAs and SAs receiving grants under Model 1 were instructed to open account with Reserve Bank of India. Detailed guidelines to open account with RBI were issued vide this office OM no. MST/PRAO/TSA/Model 1&2/2022-23/ 23 dated 27th May, 2022 (copy enclosed).

2. Since, operational difficulties were reported by CNAs and SAs in opening of accounts with RBI, Ministry of Finance, Department of Expenditure was requested to convert above schemes to Model 2 from Model 1. Department of Expenditure vide their OM 3(16)/PFMS/ 2022 dated 15^h March, 2022 (Annexure-A) have consented to convert above schemes to Model 2 from Model 1. In view of the change of above schemes from Model1 to Model 2 accounts already opened by CNAs and Implementing Agencies with RBI may be closed. Above two schemes of DST will now, be implemented as Model 2 as per details given below.


