Extension of Approval of Affiliation

The Extension of Approval of Affiliation (EOAA) has been issued to Jaipur Engineering College & Research Centre, Jaipur for the period of 5 years from the session 2017-18 to 2021-22 vide F(17)/Acad.I/Affiliation/Engg./17/2017-18/4228-34 dtd. 20.09.2017.

Further, on the directions of the 65th Board of Inspection vide Agenda No. 65.4 and subsequent approval of Hon'ble Vice Chancellor, Rajasthan Technical University, Kota, the EOAA for the institute is continued in category A for the academic session 2020-21, with the awarded Quality Index Value (QIV) of 874. The EOAA has been granted for the courses, with their approved intake, as per AICTE approval vide letter No. North-

SN	Mandatory conditions abiding to the Institute	
1	Affiliated institute shall follow and fulfill all mandatory requirements as per prevailing AICTE/COA/Government (Central/State)/ Rajasthan Technical University Act/Statutes/Affiliation Regulations to provide/maintain quality education.	
2	Affiliated institute shall follow all the instructions issued from time to time by the University and to furnish all the information and statistics desired by the University.	
3	Affiliated Institute shall not be indulged in any such activity which directly or indirectly favors illegal commercialization of education.	
4	As being a registered Society/Trust, the periodical elections for various posts enunciated in the constitution therein must be ensured with transparency and its proceedings shall be sent to university.	
5	In accordance with provisions under Statute-26(2) of Rajasthan Technical University, Kota Act, 2006 University representative shall be nominated in its governing body. Proceedings of all such meetings should be held in his presence.	

The awarded 5 years EOAA shall be valid subject to the following conditions:

1. The institute has to submit affiliation form and prescribed fee (Affiliation and Inspection fee) every year as per University's affiliation regulation and affiliation fee rule.

2. Institute shall maintain it's QIV ≥ 600 throughout 5 years of EOAA.

3. University shall revise the period of EOAA to 3 years / year wise as per the verification of QIV on the basis of the affiliation details submitted by the institute from the respective academic session. University may carry out the inspection, as per the requirement, for the verification of QIV.

One time EOAA granted to the institute shall be revised / withdrawn on the verification of the non fulfillment of any mandatory requirements as laid down by AICTE/COA/RTU. The same will also

applicable on the verification of any serious compliant against the institute.

5. The EOAA shall be amended as per the approved course(s), with their intakes, for the engineering program

as per the Extension of Approval (EOA) of AICTE for the respective academic session.

The EOAA will be immediately withdrawn on the closure of engineering program/institute by AICTE and also on the non submission of AICTE Extension of Approval (EOA) before the expiry of the granted one time EOAA.
