The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to Jaipur Engineering College and Research Centre, Shri Ram Ki Nangal, Sitpura RIICO EPIP Gate, Jaipur-302022, Rajasthan as a whole.
